4-Game Qualifying & One Game Elimination Rounds

- Each Team will bowl a 4-game series to determine their Qualifying Score

First Round Elimination

- **50%** of all teams will qualify for First Round Elimination based on Qualifying Score . (Even # of teams-50%-Odd # of teams, 1 less than half)
- Brackets will be seeded by Qualifying Score with byes awarded as necessary to narrow the field. (Same as Sr. Mini-Match Format)

Final Elimination Rounds

- Winners of First Round move to Second Round with 1-game elimination and continue until a winner is determined.

ENTRY FEE -\$100 per Team

- Bowling - \$18 Expense - \$5 Prize Fund -\$77
- \$200 Added Prize Money Contributed by Sponsors
 - Minimum First Prize - \$ 400 Based on 30 or more Teams
 - Minimum Second Prize - \$ 200 Based on 30 or more Teams
 - All Qualifiers – Minimum - \$120 Based on 20 or more teams
 - High Team Game in each qualifying game paid from Prize Fund subject to the number of teams
 - Highest Non-Qualifying Team with combined age of 140 or more wins \$50. (Minimum 3 eligible teams)
 - Optional Individual Side Pots

Entries Close November 1st. Walk-ins will be accepted ONLY IF we have 16 teams entered by October 29, and only if we have spots available.

TOURNAMENT RULES

1. Each team shall consist of two bowlers on a non-handicap basis.
2. Each team must have a combined age of 120 years or older, as of the day of the tournament. All bowlers must be at least 50 years of age, as of the day of the tournament.
3. All bowlers must be USBC sanctioned
4. 50% of the teams entered will make up the field for the match-game portion of the tournament. (If odd # of teams, one less qualifier than 50%) Byes, if necessary, will be awarded to the highest qualifiers.
5. Any ties for the final qualifying position or match games will be determined by a 9th/10th frame roll-off.
6. The match portion shall consist of single game elimination matches.
7. USBC rules and the tournament manager will resolve any disputes not covered by these rules.
8. Teams that cannot continue during the matches will forfeit that match.
9. Employees of the host-bowling establishment are permitted to enter the tournament.
10. This tournament will count as of one of the 4 tournaments required to participate in the Senior (55+) and Super Senior (65+) Mini-Match Championships.
