### 4-Game Qualifying

- Each Team will bowl a 4-game series to determine their Qualifying Score. 50% of all teams will qualify CASH – Minimum \$110. (If odd # of teams, one less than 50%).
- The HIGHEST EIGHT (8) qualifying teams (or less subject to # of entries) will bowl a one game head to head elimination game. Teams seeded by qualifying score. 1 vs 8 etc. Draw for lanes. NO Carry-Over .
- The FOUR winners of the match games will bowl TWO (2) games – SHOOTOUT format, No Carry-Over, to determine the Champion. Prizes will be awarded 1-2-3-4. Teams will switch lanes after the first game.

## TOURNAMENT RULES

1. Each team shall consist of (3) bowlers on a non-handicap basis.
2. **MAXIMUM TEAM AVERAGE IS 640, Using Last Years Highest USBC Sanctioned average for 21 or more games.**
3. All bowlers must be at least 50 years of age, as of the day of the tournament.
4. All bowlers must be USBC sanctioned. USBC # Must be provided on entry.
5. Minimum of 50% of the teams entered will CASH . The HIGHEST EIGHT (8) qualifiers (Or less subject to the # of entries) will make up the field for the ELIMINATION portion of the tournament. If odd # of teams, one less than half.
6. The Winners of the Elimination Games will qualify for the SHOOTOUT Round.
7. Any ties for the final qualifying position of the SHOOTOUT games will be determined by a 9<sup>th</sup>/10<sup>th</sup> frame roll-off.
8. If the top two teams in the final two-game round tie, a one-game roll-off will determine the winner, using BAKER FORMAT.
9. USBC rules and the tournament manager will resolve any disputes not covered by these rules.
10. Teams that cannot continue during the matches will forfeit that match.
11. Employees of the host-bowling establishment are permitted to enter the tournament.
12. This tournament will count as of one of the FOUR (4) tournaments required to participate in the Senior (55+) Mini-Match and Super Senior Championships.
